### FALL 2010/SPRING 2011 FINANCIAL CONTRACT

#### **HFC CLUB FEES:**

All fees must be paid by the due date or the Club reserves the right to suspend a player from participating in training and games until fees have been paid.

Since training is set up in advance, training fees must be paid whether or not the player attends each session. In an attempt to lessen the financial burden, the Club has adopted a payment plan below.

Annual Fees	Division 1 & Super 2 Train 2-3 days/wk
Registration fee (Due by June 22 <sup>nd</sup> )	\$ 200.00 one time
Club Dues (July to February; due by 22 <sup>nd</sup> )	\$ 87.50 per month
<b>Total Due</b>	<b>\$ 900.00</b>

#### **Multiple Child Discount Policy**

Families with three (3) children rostered on HFC teams will receive a discount of 50% on their club dues for the third child; a fourth child rostered on a HFC team will receive a 75% discount on that child's club dues.

#### **Scholarships**

Scholarships are available on a case-by-case basis at the discretion of the Club. Applications are reviewed solely by Club administrators and the information offered is held in the strictest confidence. It is the goal of this club to offer training to qualified athletes, regardless of financial constraints. Assistance is given for Club Dues based on applicant eligibility.

#### **Late Payments**

**NO PLAYER WILL BE PUT ON A ROSTER UNTIL REGISTRATION FEES HAVE BEEN PAID.**

Registration Fees and Club Dues must be paid on the date outlined on the table above. Players who are overdue will be suspended from the team effective immediately from the 5<sup>th</sup> of month and will not be permitted to train or play until arrangements are made to bring the account up to date. This process will be in place each month from July to October until each player has paid all their fees.

#### **Refunds**

The registration fee represents a partial payment for the administrative costs of the club for the soccer year (the remaining administrative costs are collected in the payments collected in the fee schedule). Administrative fees are required in order to ensure the orderly operation of the Club and to maintain the Club's offices, communications, administrative support, etc. Therefore, refunds of administrative fees will not be granted to those who have paid and then leave for another club or decide to quit. In general, all applicable administrative fees and club fees will be deducted prior to refunding any money to any player choosing to leave the club for any reason during the year.

If a team has not been registered (through EDDOA or STYSA) and a player leaves due to medical issues or moves out of the area, the registration fee will be returned, minus a \$50 administrative fee. If the team has been registered the fee will be returned minus registration, insurance, and administrative fees.

If a team is disbanded by the club for any reason (e.g., lack of players, non-competitive) the club will make its best effort to assign the remaining players to an appropriate team. If the club does not offer a position to a remaining player, the individual will be refunded a prorated portion of the club fees only.

If an individual player elects to leave a team due to actions taken by the Club, or the team with permission of the Club, (e.g., change in coach, change in players, or change in training schedule) no refunds will be given.

### **HFC TEAM FEES:**

#### **Association/League Fees**

The Club pays each team's association and league fees. Association and league fees are the costs charged to each team from the Association and league (e.g., EDDOA, STYSA) that the team plays in. These fees include the game fees, player registration fees, performance bonds and other fees charged by the association. The teams are responsible for association fees which exceed \$1,500 and will divide these costs equally among the players.

#### **Tournament and Cup Expenses**

Teams are responsible for Tournament and Cup expenses and other miscellaneous items. Typically these will run about \$150- \$200/ season per player not including travel and lodging. Tournaments are a team function and divided equally between all of the registered players.

#### **Miscellaneous Expenses**

The team may incur a variety of other expenses in the operation of the team. These may include team bonding or social events, league protests or grievances, team tents/bench and other expenses.

#### **Game Kits and Practice Uniform Costs**

Game Kits and Practice Uniforms are ordered through your team manager.

2010/2011 Game Kits will be good through spring 2012 and Practice Uniforms will be good indefinitely
